Fees and Charges

Enrolment Fees

On submission of an Enrolment Application to the School Registrar, a fee of \$50 per student is payable. A fee of \$250 per student is payable on confirmation of enrolment. Enrolment fees are non-refundable.

Tuition Fees

The tuition fees cover the cost of salaries, professional development and general classroom expenses for all classes and specialist teaching areas. Also included are:

- Levies to cover the cost of art and craft materials, text books, subject materials and equipment, physical education equipment and library resources
- Excursions and activities
- Year Book
- Student Accident Insurance
- National Benchmark Testing (Years 3, 5 & 7)

Tuition fees do not include the cost of stationery, school camps, swimming and voluntary extra-curriculum activities such as school sport and music tuition.

Stationery

Stationery and booklist supplies are at an additional cost to the tuition fees. During Term 4 the school will provide families with a link to access a list of required stationery for each year level for the following year. Orders can be placed online through Campion Education (Aust) Pty Ltd for delivery or pick up.

Camps

A School Camp is part of our outdoor education program. This fee will be billed separately and added to school fee accounts. Payment is to be made prior to the camp.

Voluntary Building Fund

This is a voluntary contribution which is used to service existing school building loans and to contribute towards the school's building programme. Families are encouraged to donate \$390 per year to the Building Fund. Please see your contribution as being essential to meeting the commitments incurred and the ongoing maintenance and development of the school. Donations are tax deductible.

Early Payment Discount

A 5% discount on tuition fees is offered if the year's fees and building fund donation are paid in full by February.

School Card

School Fee Accounts

Annual tuition fees and charges are added to school fee accounts at the commencement of the year. Additional charges may be applied during the year for camps, sports fees etc.

No reduction in any fees will be made as the result of a student not participating in any official school event, eg school excursions and testing etc.

There will be no reimbursement of school fees when students take voluntary leave eg holidays with parents.

Students enrolled after the beginning of the year are charged pro-rata for the remainder of the year.

Payment Method

Payment of school fees is via Direct Debit on the online FACTS Management System.

Direct Debit via the FACTS Management system online portal is our payment method and the only option available for monthly, fortnightly, weekly, annual and term instalments. Payments can be made from credit card or bank accounts.

Please note that EFTPOS, BPay, Credit Card and Direct Credit facilities are NOT available for payment of school fees etc.

Payment Plans

Families may negotiate payment plans directly with the Business Manager. These payment plans may be reviewed at the discretion of the Business Manager.

Overdue fees

If fees are overdue, the school reserves the right to charge a late payment fee or send defaulting families to a debt collection agency to collect fees on its behalf. The school will not be liable for any fees that a debt collection agency may charge.

If fees and other charges are in arrears, the Principal may request the withdrawal of a student until payment of the outstanding fees and charges has been received.

Early Learning and Out of School Hours Care

Early Learning Centre

Fees are invoiced and emailed on a fortnightly basis. Payment is due within two weeks of the date of the invoice. Vacation Care is also available for ELC students. Child Care Subsidy is applicable for all eligible ELC families.

Out of School Hours Care (including Vacation Care)

Fees are invoiced and emailed on a fortnightly basis. Payment is due within two weeks of the date of the invoice. Child Care Subsidy is applicable for all eligible SPLOSHC families.

Notice of Student Withdrawal

A full Term's notice must be given in writing advising that a student will be leaving the school, or not returning for the following year. If such notice is not given, one Term's fees will be payable in lieu of notice. This applies to all students commencing at the school once enrolment confirmation has been received.
